- 1. Name of the Trust:** The name of the trust hereby established shall be **SHIVANAGERE EDUCATION TRUST**.
- 2. Registered office:** Registered of the trust shall at SKG Mill Complex, Bukkapatna Road, Sira, Tumkur District. The location of the office of the trust may changed to any other place as the board of trustees in office may from time to time determine, having regard to the satisfactory performance of the object of the trust.
- 3. Objects of the trust:** The sole object of the Trust is to promote education which shall be broadly charitable in character and conduct. They are stated as here under:
 - To establish, acquire, promote, maintain and run school, college, paramedical and technological training colleges, nursing college, industrial training centers, orphanages and residential schools and allied educational institutions to import basic and advanced education, grant scholarship and awards to deserving and needy, for promotion of education and learning in all branches and more specifically in science and technology.
